Said lot having according to said plat the following courses and distances, to-wit:

Beginning at a point on the North side of Hunt Street, corner of Lot No. Three (3) and running thence with Hunt Street N. 34-30 E. fifty (50) feet to corner of Lot No. Five (5); thence with line of Lot No. Five (5) N. 55-30 W. one hundred fifty-three feet to iron pin, corner of Lots Nos.
