Whereas, by deeds of W. P. Sloan to C. E. Sloan, dated Sept. 25- 1936; recorded in Vol. 187, P. 352, and of C. E. Sloan to Annie E. Sloan, dated Feb. 18- 1937, recorded in Vol. 198, p. 110, all of lots Nos. 7, 8 and 9 on plat of the H. J. Lanford property were described as included in such conveyances, when in fact only Lot #9 was intended by such conveyances to be described, included and conveyed, and it is now desired to correct such conveyances and re-instate title to lots 7 and 8 in and to W. P. Sloan, which last two lots #7 and #8 were erroneously included therein, and to disclaim any title to or interest in said #7 and #8 by or in favor of the said C. E. Sloan and Annie E. Sloan, now, therefore,

KNOW ALL MEN BY THESE PRESENTS, That we, C. E. Sloan and Annie E. Sloan,

in the State aforesaid

in consideration of the sum of One dollar, and correction of said deeds,

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain sell and ~~quit-claim~~ <sup>quit-claimed</sup> ~~claim~~ <sup>quit-</sup> release, unto the said W. P. Sloan, his heirs and assigns forever:

Those two certain lots of land in Chick Springs Township, said County and State, known and designated as Numbers 7 and 8 on a plat of the H. J. Lanford property, prepared by H. S. Brockman, Mar. 27th, 1928, and thereon delineated as follows:

Beginning on eastern edge of Wood Street at corner of lot #6, and runs thence S. 85-55 E. 147.6 feet to joint corner of #7 and #10 lots: thence N. 19-45 E. 100 feet to joint corner of #8 and #9 on line of #10; thence N. 81-51 W. 149.2 feet to stake on edge of Wood Street; thence with said Wood Street, S. 17-55 W. 110 feet to the beginning corner.

By above disclaimer and conveyance, Lot #9 is left still in the name and ownership of Annie E. Sloan, which on said plat is recorded as follows:

Beginning at the intersection of Wood Street and Old National Highway, and runs thence with said old Highway, S. 79-30 E. 150 feet to corner of #10 (Earle Duncan corner) on said highway; thence with Duncan Line S. 19-45 W. 49 feet to corner of lot #8; thence N. 71-51 W. 149.2 feet to edge of Wood Street; thence with Wood Street, N. 17-52 E. 55 feet to the beginning corner.
