

EXCHANGE PLANT PERMIT.

Received of the SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY, One dollar in consideration of which I hereby grant unto said Company, its associated and allied companies, their respective successors and assigns, the right, privilege and authority to construct, operate and maintain its lines of telephone and telegraph, and for the general transmission of intelligence, including the necessary underground and aerial cable, conduit, poles, wires and fixtures with the further right to permit the attachment of the wires of any other company, or person, to said poles and fixtures upon and over or under the property which I own near the City of Greenville, County of Greenville and State of South Carolina; said sum is received in full payment of said right.

The above mentioned property being that tract or lots of land known and designated on plat of "Highland Terrace", as recorded in office of R. M. C. for Greenville County, in Book D, Page 238.

The following is a description of the location in which the said lines shall be constructed and maintained;

Lots Fronting on Hill Crest Drive and Fairview Avenue

Line to be constructed in alley back of lots fronting on West Hill Crest Drive and Fairview Avenue.

Lots Fronting on Townes Street

Line to be constructed along the side property lines of lots No's. 9 and 11 from Townes street to rear property line of said lots, thence along the rear property lines of lots fronting on Townes Street, and also on that property adjoining the rear property lines of said lots.

Lots Fronting on Finley Street

Line to be constructed along the rear property lines of lots fronting on Finley Street, and also on that property adjoining the rear property lines of said lots.

Line to be constructed along the necessary streets, drives, avenues or roads as shown on plat.

In addition to the rights conveyed above, the Telephone Company is authorized the right to trim trees so as to clear and keep cleared said Company's plant; said sum is also received in full payment of said rights.

The Telephone Company agrees to re-locate at its own expense, on said property, its lines and fixtures to conform with future building improvements.
