Hudson in consideration of the sum of One (\$1.00) Dollar to us in hand paid, receipt of which is hereby acknowledged, and for other valuable considerations, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the County of Greenville, its successors and assigns, a right-of-way as hereinafter described, on and over all lands which we may own in whole or in part.

It is the intention of the deed to convey such parts, parcels, or strips of our land that may be needed to convey a right-of-way of sections of the Old County Home Road and Parker Road, having the width of Forty (40)' Feet, that is, Twenty (20)' feet on each side of the center line, as staked out by the Engineer, except where there should be a cut or fill, may be necessary for extra width.

This right-of-way beginning at William Weaver on the left running to Roy Hudson Corner, along said road.
