It is the intention of the Deed to convey such parts, parcels, or strips of our land that may be needed to convey a right-of-way of sections of the OLD COUNTY HOME ROAD and PARKER ROAD, having the width of Forty (40') Feet, that is, Twenty (20') Feet on each side of the center line, as staked out by the Engineer, except where there should be a cut or fill, may be necessary for extra width.

This right-of-way beginning at H. E. Stewart extending to Mrs. Edward Hudson on the right ending at Mrs. Lloyd Dawson corner on left.
