All that certain piece, parcel or lot of land, situate, lying and being in the County and State aforesaid, on the Northeast side of Sylvania Avenue, just off Paris Mountain Road, being known and designated as Lot No. 13 on plat made by Dalton and Neves, Engineers, June 1938, of "Leawood" property of C. M. Gaffney, Trustee, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book "J" at pages 18 and 19, and being more particularly described as follows:

Beginning at an iron pin on Sylvania Avenue, joint corner of Lots 12 and 13 and running thence N. 33-54 E. 180 feet to an iron pin; thence S. 56-06 E. 77 feet to an iron pin joint corner of lots 13 and 14; thence S. 33-54 W. 180 feet to Sylvania Avenue; thence with Sylvania Avenue N. 56-06 W. 77 feet to the beginning corner.
