to me Earline Vaughn Campbell in hand paid, at and before the sealing of these presents by the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said Earline Vaughn Campbell.

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about two and one half miles North West from the Town of Greer, near Fairview Baptist Church, and being shown and designated as lot No. 7 on plat of property of R. B. Vaughn as prepared by H. S. Brockman, Surveyor, June 26th, 1940, and having the following courses and distances, to-wit:-

Beginning on an iron pin on the North West back of the road, that was formerly known as the Mosteller road and which now connects the Buncombe Road with the Gilreath Mill Road, and being the corner of lot No. 6, and runs thence with the said road N. 47-24 E. 229 feet to an iron pin on the bank of the road and on the line of Mrs. Crain's property; thence with the Crain line N. 72-00 W. 295.5 feet to an iron pin on the Crain line and at the intersection of the 20 foot proposed road; thence with the proposed road S. 45-09 W. 94.5 feet to an iron pin and corner of lot No. 6; thence with the line of lot No. 6 S. 44-59 E. 254 feet to the beginning corner.
