

TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, That S. Slater & Sons, Inc.,

a corporation chartered under the laws of the State of Delaware, and having its principal place of business at
Slater, in the State of South Carolina, for and in consideration of
the sum of Nine Hundred Fifty & no/100 (\$950.00) DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged)
has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Jessie Mae Smith, her heirs and

assigns:-

All that certain piece, parcel or lot of land on the East side of Lindburg Street, in the Village of S. Slater & Sons, Inc., at Slater, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 29 of Block C, as shown on a plat of the Village of S. Slater & Sons, Inc., made by J. E. Sirrine & Company, Engineers, on July 10, 1940, which plat is recorded in the R. M. C. Office for Greenville County, in Plat Book K, at pages 63, 64, and 65, and having, according to said plat, the following metes and bounds, to-wit:-

Beginning at an iron pin on the East side of Lindburg Street, joint front corner of Lots No. 29 and 30 of Block C, and running thence with the line of Lot No. 30, S. 76-40 E. 130.1 feet to an iron pin, joint rear corner of Lots No. 7 and 8 of Block C; thence with the rear line of Lot No. 8, N. 32-30 E. 54.8 feet to an iron pin in the rear line of Lot No. 8, joint rear corner of Lots No. 28 and 29; thence with the line of Lot No. 28, N. 60-45 W. 158.8 feet to an iron pin on the East side of Lindburg Street; thence with Lindburg Street, S. 24-11 W. 48 feet to an iron pin; thence continuing with Lindburg Street, S. 2-30 E. 50 feet to the beginning corner.

The grantor reserves to itself, its successors and assigns, all water and sewer pipe lines, electric light and power lines, valves, fittings, hydrants, poles, wires, transformers and other apparatus used in connection with and forming a part of the water, fire, electric light and power distribution and sewerage systems of the Village of S. Slater & Sons, Inc., at Slater, S. C. which may be located on the lot herein conveyed, together with the right and easement, in respect to so upon the land for the purpose of maintenance, repair and operation of said water, sewer, electric light and power lines, as same are now located, to remove and relocate said lines as to run in or along the street, and to operate and maintain the lines as so relocated, but this reservation shall not include the individual house water and sewer pipe lines serving the house on the lot herein conveyed as the same are located on said lot.

It is contemplated that there will be organized a district or districts in accordance with the provisions of Act No. 784 of the Acts of 1934 of South Carolina or other applicable law, and that the grantor herein may transfer the water, fire, electric light and power lines, and sewerage lines in said village to such district or to a public service corporation, or in part to such district, and in part to a public service corporation, and thereupon the grantor's responsibility, in any way with reference to the operation or maintenance of any of the utilities in said village, shall terminate.

It is understood and agreed that the conveyance of the above described lot is made subject to the following restrictions:-

- (1) That the lot above described shall not be sold, leased or released to any negro or person of negro blood.
- (2) That no mercantile establishment shall be erected, operated or maintained on the lot above described.

The above restrictions are uniform and will appear in the deeds to all lots sold by the grantor from the above mentioned plat.
