All that certain piece, parcel or lot of land, situate, lying and being in the County and State aforesaid, on the Eastern side of Paris Mountain Road, being known and designated as Lot No. 3 on plat made by Dalton & Neves, Engineers, June 1938, of "Leawood" property of C. M. Gaffney, Trustee, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book "J" at Pages 18 and 19, and being more particularly described as follows:

Beginning at an iron pin on Paris Mountain Road 70 feet from the intersection of Paris Mountain Road and Sylvania Avenue and running thence S. 42-18 E. -217 feet to an iron pin in line of Lot No. 44; thence S. 33-54 W. 71.8 feet to an iron pin; thence N. 55-41 W. 66 feet along rear line of Lot No. 43; thence along line of Lot No. 2 N. 42-04 W. 176.2 feet to an iron pin on Paris Mountain Road; thence with Paris Mountain Road N. 52-0 E. 85 feet to the point of beginning.
