All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, containing 1/2 one half an acre more or less and being a part of the land conveyed to A. H. Whitaker by E. Inman, Master, and being a part of the land known as the Aaron Walker home stead; having the following metes and bounds, to-wit:

Beginning on the bank of standing spring road and running N. 76 1/2 W. 3 chains 48 links to a pine tree, thence N. 1 1/2 E. 3 chains 59 links to L. D. Mitchell's line, thence with T. E. Honeycutt's line to the beginning corner.

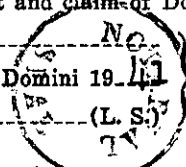
