to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released; and by these presents does grant, bargain, sell and release unto Lula G. Patton

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, containing 16-1/5 acres, more or less, and being described according to Plat of R. E. Dalton, Engineer, dated November 23, 1921, as follows:

Beginning at corner of land of Garrison and grantee on stone, and running thence with grantees land S. 39 1/2 W. 7.90 to Hickory; thence with grantees line S. 29 1/2 W. 18.15 to stone; thence N. 64 1/4 W. 3.74 to stone; corner of Garrison land and another tract of land being conveyed this day to Gladys M.
