(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Catesby W. Willis and J. M. H. Willis, share and share alike, as tenants in common, all the right, title, interest and estate of said B. P. Willis in and to those two certain adjoining parcels of land in Gantt Township, Greenville County, State of South Carolina, about 5 or 6 miles from the Greenville Court House on the east side of Augusta Roaz, doscribed as follows:

1st. A tract of 10 acres, beginning at an iron pin on the east side of Augusta Road corner of Aug. W. Smith land, and running thence with Aug. W. Smith's line N. 68-18 E. 1613.6 feet to an iron pin; thence still with Smith's line S. 12 E. 271.6 feet to iron pin, corner of other property hereby conveyed formerly W. P. Chiles; thence still with Chiles! land S. 68-18 W. 1655 feet to iron pin on Augusta Road; thence with Augusta Road N. 3-45 W. 284.5 feet to the beginning; it being the identical real estate conveyed unto Edna E. C. upon duly authenticated copy of said will and probate proceedings on the 14th. day of March, 1941, by which will the said Edna E.
