

any location, storage or basin, its successors and assigns, oil water and power pipe lines, right of way and other rights, fixtures, buildings, materials, gas, water, transportation and other apparatus, fixtures and equipment of all kinds of the owner, gas, heating, electric light and power companies, telephone and telegraph companies, together with all other instrumentalities, especially to go upon the land for purposes of maintenance, repair and operation of said water, power, electric light and power lines, as well as to erect, to remove and relocate, and from time to time to run in along the streets, and to operate such water, power, electric and gas lines on the lot above described, and to connect the individual house water and gas lines to the lines on the lot above described, so far as the same extend on said lot, and the lot of the city of Brownsville, or there will be established a district pursuant to the provisions of any charter law, water, fire protection, sewerage, lighting and power distribution systems in said district or to a public service corporation, or in part to such district, and in part to corporation or corporation of any of the utilities in said village shall cease.
