to the undersigned owner(s) paid, receipt of which is hereby acknowledged, the undersigned hereby grant(s), bargain(s), sell(s), convey(s) and warrant(s) to PLANTATION PIPE LINE COMPANY, a Delaware Corporation, its successors and assigns, a right-of-way and easement for the purpose of constructing, maintaining, operating, altering, repairing, removing, changing the size of, and replacing pipe for the transportation as a common carrier for hire of oil, crude petroleum and refined petroleum products or combinations thereof or similar thereto, natural and artificial gas, casinghead and natural gasoline and any other liquids or gases, the Grantee to have the right to select the route, under, upon, over and through the lands situate in the County of State of South Carolina, described as follows:

4.00 to an angle; thence S. 30 $\frac{1}{2}$ E. 12.20 to an angle; thence S. 34 $\frac{1}{2}$ E. 11.50 to an angle; thence S. 19 $\frac{1}{2}$ E. 15.00 to a stone on Scuffletown Road near W. S. Thackston corner; thence N. 83 $\frac{1}{2}$ W. 14.37 to a stone Will Garrett's corner; thence S. 22 $\frac{1}{2}$ W. 29.12 to a stone; thence S. 59 $\frac{1}{2}$ W. 28.82 to a stone; thence S. 36 $\frac{1}{2}$ E. 6.65 to beginning corner.
