All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

on the north side of Kenwood Lane (formerly Heston Avenue), and being known and designated as Lot No. 80, of a subdivision known as North Park, as shown on plat thereof recorded in the R.M.C. Office for Greenville County, in Plat Book K, at pages 48 and 49, and having the following metes and bounds, to-wit:
