the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said  
Josie McSweeney:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, being known and designated as Lot No. 45, on a plat of Morgan Hill addition, recorded in the R. M. C. Office for Greenville County in Plat Book A, pages 68 and 69, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Morgan Street, joint corner of Lots 45 and 46, said point being approximately 389 feet west from the southwest intersection of Morgan Street and Monaghan Road, and running thence along the joint line of Lots 45 and 46, S. 7 1/4 E. 200 feet to an iron pin, joint rear corner of said lots; thence S. 82 3/4 W. 60 feet to an iron pin, joint rear corner of Lots 44 and 45; thence with the joint line of said lots, N. 7 1/4 W. 200 feet to an iron pin on Morgan Street, N. 82 3/4 E. 60 feet to the point of beginning.
