The above mentioned line to be constructed along the Hunt's Bridge Road, with the understanding that no poles are to be located over 25 feet from center of said road.

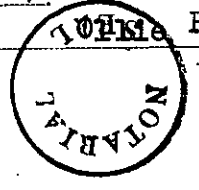
