KNOW ALL MEN BY THESE PRESENTS, That Surety Mortgage Company,

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Twenty-Seven Hundred & No/100 (\$2,700.00) DOLLARS.

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Ralph Gossett, his heirs and assigns:-

~~All those two certain pieces, parcels or lots of land situate, lying and being on the East side of North Main Street, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lots No. 8 and 9 of Block H on plat of "Northgate", revised by R. E. Dalton, May, 1939, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book M, at page 13, and having, according to said plat, the following metes and bounds, to-wit:~~

Lot No. 8 being described as follows:-

BEGINNING at an iron pin on the East side of North Main Street, joint front corner of Lots No. 7 and 8 of Block H, and running thence with the line of Lot No. 7 in an Easterly direction 200 feet to an iron pin; thence along the rear line of Lot No. 21 in a Southerly direction 83.33 feet to an iron pin at joint rear corner of Lots No. 6 and 8; thence with the line of Lot No. 6 in a Westerly direction 200 feet to an iron pin on the East side of North Main Street; thence along the East side of North Main Street in a Northerly direction 83.33 feet to the beginning corner.

Lot No. 9 being described as follows:-

BEGINNING at an iron pin on the East side of North Main Street, joint front corner of Lots No. 7 and 9 of Block H, and running thence with the line of Lot No. 7 in an Easterly direction 200 feet to an iron pin in the rear line of Lot No. 34; thence along the rear line of Lots No. 33 and 34 in a Northerly direction 75 feet to an iron pin, joint rear corner of Lots No. 9 and 10; thence with the line of Lot No. 10 in a Westerly direction 200 feet to an iron pin on the East side of North Main Street; thence along the East side of North Main Street in a Southerly direction 75 feet to the beginning corner.

This property is conveyed subject to the following restrictions and reservations:-

- (1) No building shall be erected nearer than 50 feet to North Main Street.
- (2) No dwelling shall be erected on said lots costing less than \$6,000.00.
- (3) These lots shall be used for residential purposes only, except this shall not apply as to Section D on the plat above mentioned.
- (4) The property shall not be sold, rented or otherwise disposed of to persons other than of the Caucasian race.
- (5) No obnoxious or offensive trade shall be carried on the property.
- (6) No building of a temporary structure shall be erected on the property for use as a residence.
- (7) An easement is reserved along the rear line of the lots, two (2) feet in width, for the purpose of placing sewerage, telephone and electric lines or other utilities, with the right of entry for maintaining and repairing said utilities.
