The Company agrees to re-locate at its own expense, on said property, its lines and fixtures to conform with future building improvements.

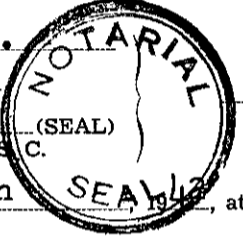
