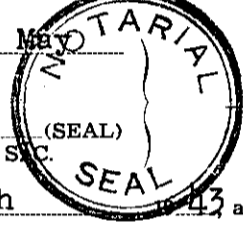

In addition to the rights conveyed above, the Telephone Company is authorized to trim and cut trees so as to clear and keep cleared said Company's plant.

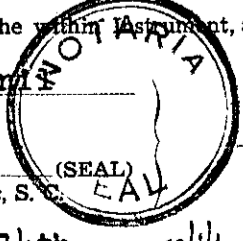
