All covenants and agreements of the parties herein shall bind and the benefits and advantages shall inure to the respective heirs, executors, administrators, successors and assigns of the parties hereto. Whenever the context requires, the singular number shall include the plural, the plural the singular, and the use of any gender shall include all genders.
