(the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said Lenora L. Going, and her heirs and assigns forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

on the north side of Griffin Avenue, now known as North Park Drive, and being known and designated as the greater portion of Lot No. 41, of a subdivision known as North Park, as shown on plat thereof, recorded in the R. M. C. Office for Greenville County in Plat Book K, at pages 48 and 49, and having the following metes and bounds, to-wit:

"Beginning at an iron pin on the North side of North Park Drive, at the joint corner of Lots Nos. 41 and 42, and running thence along the joint line of said lots, N. 19-06 E. 117.5 feet to an iron pin in line of said Lot No. 42, at the corner of other property of the grantor herein; thence along the line of that property, S. 68-34 E. 68 feet to an iron pin, on the west side of an unnamed street; thence along the line of said unnamed Street, S. 12-47 W. 104 feet to an iron pin, on said unnamed Street; thence following the curvature of said unnamed street 20 feet to an iron pin on the north side of North Park Drive; thence along the line of said North Park Drive, N. 68-34 W. 69.5 feet to the beginning corner."
