TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, R. N. Smith County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembly of South Carolina and the statute laws of said State, against K. O. Wright, Farmers Loan & Trust, T. O. Badgett & W. M. Capps

defaulting taxpayer(s) of said County, strictly charging and commanding said Delinquent Tax Collector of said County to levy by distress and sale of the lands of the said K. O. Wright, Farmers Loan & Trust, T. O. Badgett, W. M. Capps

tax defaulter(s), the sum of forty six & 74/100 dollars including the penalties on said tax execution(s) for the year(s) 1927, 1930, 1931, 1932

together with charges and costs thereof; and Whereas, by virtue and authority of said warrants W. A. Hopkins the delinquent tax collector of the State and County aforesaid, did on the 9th day of March 1936 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of May during the usual hours of sale, after due advertisement, sell the same to The Forfeited Land Commission and their assigns or successors the purchaser(s), hereinafter known as "grantee(s)," and the highest bidder at such sale, for the sum of forty six & 74/100 dollars and gave a receipt for said purchase money to them; and

WHEREAS, more than twelve months have elapsed since the date of said sale, and the defaulting taxpayer(s), or any other party interested, have failed to redeem said land so sold for taxes;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That I, M. L. Ashmore, Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of forty six & 74/100

Dollars to me paid by the said grantee(s), The Forfeited Land Commission have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee(s), The Forfeited Land Commission, their assigns or successors;

All that certain piece, parcel or lot of land being and lying in Greenville County, State of S. C. being known and designated as lot No. 3 of the subdivision known as Verner Heights, having the following metes and bounds, to-wit: Beginning at an iron pin on the North side of Riverside Road and running thence N. 10 1/2 E. 150 ft. to an iron pin; thence N. 65 W. 60 feet to an iron pin; thence S. W. 150 feet to an iron pin on the Riverside Road; thence S. 65 E. 70 feet to the beginning corner.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining,

To have and to hold all and singular the premises hereby granted, with the appurtenances, unto the said The Forfeited Land Commission or successors their assigns forever, according to the form in force and effect of the laws and usages of the State of South Carolina in such cases made and provided.
