All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina.

on road near Lowndes Hill Road, adjoining property of Greenville Airport, containing two acres, and having the following metes and bounds, as shown on plat of property of H. C. Harvley, made by Dalton & Neeves, Engineers in August, 1939 and amended in September, 1942, to-wit:

BEGINNING at an iron pin on the west side of said road, and running thence along the said road S. 24-07 E. 250 feet to a point on west side of said road; thence across an iron pin on the east side of said road N. 62-22 E. 369.5 feet to an iron pin; thence N. 1-36 E. 129 feet to an iron pin in line of property of Greenville Airport; thence along line of said Airport property N. 88-24 W. 325 feet to an iron pin; thence S. 53-08 W. 135.5 feet to the beginning corner.
