ASSIGNMENT

WHEREAS, on Nov. 18, 1939, by written instrument, now of record in the R. M. C. Office for Greenville County, State of South Carolina, in deed Book 216 at page 259 Constance D. Dooley, Malcolm C. Davenport, Luther M. Davenport, Martha D. McCleery and Dan D. Davenport, appointed and constituted the Peoples National Bank of Greenville, as Trustee, for the purposes stated in said instrument, and,

WHEREAS, Malcolm C. Davenport is now indebted to the Peoples National Bank of Greenville, S. C., and is desirous of securing said indebtedness,

NOW THEREFORE, in consideration of \$1.00 and other valuable consideration to me in hand paid by the Peoples National Bank of Greenville, S. C., the undersigned, Malcolm C. Davenport, does hereby assign, transfer and set over unto the Peoples National Bank of Greenville, S. C., all his right and interest in and to, and accruing from said trust above referred to and the exclusive right, title and interest in the distribution of the proceeds from said trust which have accrued or may hereafter accrue to the undersigned until such time as the said indebtedness due the Peoples National Bank of Greenville, S. C. has been paid in full, and this instrument shall constitute the authority of said bank, as trustee, under said trust to pay to itself individually my distributive share of the proceeds from said trust until said indebtedness has been paid in full.
