M. Moore (the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said Reverend A. M. Moore, Greenville Township, Greenville County, State of South Carolina. All that piece, parcel or lot of land in

All those certain lots of land in Greenville Township, State of South Carolina, known as lots nos. 2 and 3 in Block E, in the Subdivision known as Summitt View, plat of which is recorded in R. M. C. Office for Greenville County in Plat Book A, page 75, said lots having frontage of 50 feet each on New Cut, or Bramlett Road, with a depth of 150 feet, more or less.

It is understood and agreed that Creole Street, as shown on said plat, has been relocated since the recording of said plat, and this conveyance is made subject to the present location of Creole Street.

Also this deed covers Church Building now on above said lots.
