to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Otis E. Ridgeway

All that certain piece, parcel or lot of land, situate, lying and being in Greenville County, State of South Carolina and being known and designated as Lots Nos. 28 and 29 of Block A, Woodland Subdivision, property of Piedmont Corporation, as per plat recorded in Plat Book J, pages 70 and 71, to which reference is hereby made. Said lots are located on West side of Chapman Street.

This conveyance is made subject to restrictions recorded with above mentioned plat. The grantor is to pay all taxes up to and including the year 1942.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

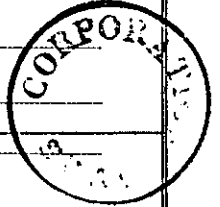
TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinabove named, and his heirs and assigns forever.

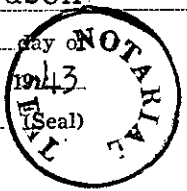
