This matter comes before me on petition of Oscar H. Doyle, United States District Attorney, by W. H. Arnold, Special Assistant, praying that certain errors in the above-entitled proceeding be corrected.

After due consideration of said petition,

IN IS ORDERED, That the Judgment on the Amendment to Declaration of Taking No. 1 filed herein February 17, 1943, be amended by striking therefrom the source of title relative to Tract No. 40 and inserting therein after the description by metes and bounds of said Tract No. 40 a recitation to the effect that same is a part of the land conveyed to W. V. Granger by T. E. Christenberry, Clerk of Court of Common Pleas for Greenville County, South Carolina, by deed recorded in Deed Book 175, page 347, R. M. C. Office for Greenville County, South Carolina.

IT IS FURTHER ORDERED, That the source of title following the metes and bounds description of Tract No. 46 reciting that it is a part of the same conveyed to Rosa Mary Cothran by Margaret V. Wells, as recorded in Deed Book 205, page 34, of the Public Records, Greenville County, South Carolina, be stricken from the Judgment on the Amendment to Declaration of Taking No. 1 filed herein February 17, 1943, and that there be inserted in lieu thereof a recitation to the effect that it is a part of the same land conveyed to Lena Cochran by by Nora A. Foster by deed recorded in Deed Book 152, Page 345, R. M. C. Office for Greenville County, South Carolina.

IT IS FURTHER ORDERED, That the public records as shown by Deed Book 251, page 247, R. M. C. Office for Greenville County, South Carolina, be also amended in conformity with this order.
