

West boundary line of the property of S. M. Jones South 00 degrees 30 minutes West approximately 440 feet from the Northwest corner of said tract; thence South 66 degrees 30 minutes East 550.3 feet to the point of curve; thence along the arc of a 3 degree curve to the left 25.68 feet to the point on the property line common to S. M. Jones and V. L. Johnson, said point being North 6 degrees 15 minutes West 199 feet from the corner where the property line of the aforesaid mentioned tract turns South 62 degrees 15 minutes East, being a part of the same land conveyed to S. M. Jones by Lola F. Watson as recorded in Deed Book 156, page 207, Public Records of Greenville County, S. C.

TRACT NO. 46.

A tract or parcel of land lying and being in Gantt Township, Greenville County, South Carolina, containing 0.58 acre, more or less; being a 70 foot strip of land extending 35 feet on each side of and parallel to the center line described as follows: Beginning at a point on the West property line of Mrs. Rosa Mary Cothran which is North 26 degrees 35 minutes East 393.11 feet from the Southwest corner of said tract; thence along the arc of a 4 degree curve to the right 360 feet to a point on the Southeastern property line of said tract which is South 54 degrees 58 minutes West 140 feet from the Southeastern corner of the tract. Being a part of the same land conveyed to Rosa Mary Cothran by Margaret V. Wells as recorded in Deed Book 205, page 34, of the Public Records, Greenville County, S. C.

TRACT NO. 47

A tract or parcel of land in Gantt Township, Greenville County, South Carolina, being a 70 foot strip of land containing 0.923 acres, more or less, extending 35 feet on each side of and parallel to the center line described as follows: Beginning on the county road between the properties of Elise Louise Kohn and R. C. Simpson 253.35 feet Southeast from the intersection of said county road and East right-of-way of U. S. Highway No. 29; thence along the arc of a 5 degree curve to the right 142.84 feet; thence along the arc of 4 degree curve to the right 436.36 feet to a point on the property line of R. C. Simpson which is South 26 degrees 35 minutes West 15 feet from the Northeast corner of said tract. Being a part of the same land conveyed to Robert C. Simpson by John A. Bouchillon according to Deed Book 172, page 416, Public Records, Greenville County, S. C.

TRACT NO. 48

A tract or parcel of land lying in Gantt Township, Greenville County, South Carolina, containing 0.48 acre, more or less, being a 70 foot strip of land extending 35 feet on each side of and parallel to the center line described as follows: Beginning at a point on the East right-of-way of U. S. Highway No. 29, which is North 16 degrees 20 minutes East 95.7 feet from the Southwest corner of the property of Elise Louise Kohn; thence along the arc of a 5 degree curve to the right 299.5 feet to a point in the center of the county road, a common line between the property of E. Louise Kohn and R. C. Simpson, said point being 241.3 feet Southwesterly from the East right-of-way of U. S. Highway No. 29. Being a part of the land described in a deed from Oakvale Land Company to Mrs. Elise Louise Kohn as recorded in Deed Book 173, page 75, Public Records, Greenville County, S. C.

The lands above described contain in the aggregate 14.553 acres, more or less, as shown on plats designated as Tracts Nos. 15, 17, 21, 26 to 28 inclusive, 31, 33 to 40 inclusive, 44 and 46 to 48 inclusive, respectively, which plats are attached to and make a part of the Amended Petition in Condemnation and Amendment to Declaration of Taking No. 1 above mentioned;

in fee simple absolute, subject only to existing easements for public roads and highways, for public utilities, for railroads and for pipe lines therein, vested in the United States of America upon the filing of the Declaration of Taking No. 1 on September 5, 1942, and the Amendment to said Declaration of Taking No. 1 and the depositing into the Registry of the Court the sums of money therein stated as the estimated compensation of said tracts of land therein described, and all of said tracts of land are deemed to have been condemned and taken for the use of the United States of America and the right to just compensation for the property taken, upon the filing of the original Declaration of Taking No. 1 and making of the deposit and upon the filing of the Amendment to Declaration of Taking No. 1 and the additional deposit made therewith, vested in the persons entitled thereto, and the amount of compensation shall be ascertained and awarded in this proceeding and established by judgment herein pursuant to law.
