POWER OF ATTORNEY

WHEREAS, I, George Norwood, am a resident of the County and State aforesaid, and my business, business interests and my property interests are located or center there;

AND WHEREAS, other duties now necessitate my absence from South Carolina, and may continue to do so for some time, possibly for the duration of the present war in which our country is engaged, and wish to provide for all transactions necessary to protect my private interest and to facilitate the carrying on of my affairs;

NOW KNOW ALL MEN BY THESE PRESENTS that I, George Norwood, reposing special trust and confidence in my wife, Aimee S. Norwood, have made, constituted and appointed, and by these presents do make, constitute and appoint the said Aimee S. Norwood my true and lawful Attorney of Fact, in my name and stead to act in relation to said matters, giving and granting unto her full power to transact all business for me during the continuation of this Power of Attorney; to make deeds of real estate for me, wherever located; to execute mortgages of real estate for me wherever such property may be located; to execute releases of life insurance assignments; to borrow against collateral belonging to me and to pledge same in my place and stead; giving and granting unto my said Attorney of Fact power and authority to do and perform all and every act and thing whatsoever, above provided, and all things necessary to be done in and about said transactions in order to complete the same; as fully as to all intents and purposes as I might or could do if personally present, hereby ratifying and confirming all my said Attorney of Fact shall lawfully do or cause to be done by virtue hereof.

And unto these presents I do hereby bind myself, my heirs, executors and administrators.

This Power of Attorney shall continue until January 1, 1945.
