Byers, her heirs and assigns all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

in Greenville Township, known and designated as Eastern half of lot No. 30 as shown on plat of the Perry property recorded in the R. M. C. office for Greenville County in Plat Book "I" at page 33, and being more particularly described by metes and bounds, as follows:

Beginning at an iron pin on the Southern side of a six foot sidewalk running along Rogers Avenue, at the corner of lot No. 31 now owned by the grantee, and running thence along said Rogers Avenue S. 83-55 W. 25 feet to an iron pin, center of front line of lot 30; thence S. 5-50 E. through the center of said lot 150 feet to an iron pin; thence N. 83-55 E. 25 feet to an iron pin, corner of lot No. 31; thence with the line of said lot N. 5-50 W. 150 feet to the point of beginning.
