(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said  
F. J. Bishop, his heirs and assigns:

All that certain piece, parcel or tract of land on the Northwest side of South Carolina State Highway No. 29 (also known as New Super Highway, between Spartanburg and Greenville, S. C.), in Chick Springs Township, Greenville County, South Carolina, containing 6 acres, more or less, according to plat made by H. S. Brockman, September 26, 1936, and having the following metes and bounds, to-wit:

Beginning at a point in the center of Enoree River, where the center of said highway crosses Enoree River, and running thence with the center of said highway in a Northeasterly direction and crossing a small branch, to a point in center of said highway at corner of property now owned by F. J. Bishop; thence N. 81-11 W. 150 feet, more or less, to a maple 3x near branch; thence crossing branch and running S. 82-30 W. 1,138 feet to a point in the center of Enoree River; thence with the center of Enoree River S. 0-30 W. 200 feet; thence still with Enoree River, S. 11-0 W. 300 feet; thence still with Enoree River, S. 1-0 W. approximately 300 feet, more or less, to a point in said river in middle of said U. S. Highway No. 29 first above mentioned, the beginning corner.

This is a portion of the property conveyed to the grantor by deed of Southeastern Life Insurance Company, dated April 1, 1943.
