to US paid by Mavis Barfield

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Mavis Barfield

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

a short distance north of the City limits of Greenville, South Carolina, on the east side of Buncombe Road, known and designated as a portion of lot 11 according to plat of property of Mountain City Land & Improvement Company made by J. M. Southern, D. S. October 10, 1895, having the following metes and bounds, courses and distances, to-wit:

Beginning at a point on the east side of Buncombe Road, south-west corner of Taft lot and running thence N. 66 1/4 E. 201 feet to point in line of lot 31; thence with line of lot 31, S. 23 1/4 E. 25 feet to corner of lot this day conveyed by J. H. and A. M. Taylor to A. E. Barfield; thence with line of last mentioned lot S. 66 1/4 W. 200 feet, more or less, to point on east side of Buncombe Road; thence along the east side of Buncombe Road in a north-westerly direction 25 feet to beginning corner.

AND we do hereby bind ourselves, our heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Mavis Barfield, her heirs and assigns, against ourselves and our heirs, and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.
