F. Brumley, according to said survey made by R. E. Dalton, Engr., in April, 1923, having the following courses and distances, to-wit: Beginning at pipe on west side of Trotter Street, and running thence N. 56-0 W. 156.7 feet along the line of C. E. Bristoe property to point; thence N. 34-30 E. 60 feet to corner of Lot No. 2; thence S. 56-0 E. 157.1 feet along line of Lot No. 2 to Trotter Street; thence S. 34-30 W. 60 feet along Trotter Street to point of beginning. and executed and deliver a good and sufficient warranty deed therefor on condition that he shall pay the sum of one Hundred and Twenty Five (\$125.00) Dollars in the following manner Ten (\$10.00) Dollars cash and Five (\$5.00) Dollars each month hereafter payable on the 1st day of each month hereafter, beginning with Feb. 1, 1942, and so continuing until the said principal sum is paid in full, until the full purchase price is paid, with interest on same from date at six per cent. per annum until paid to be computed and paid annually, and if unpaid to bear interest until paid at same rate as principal, and in case same sum or any part thereof be collected by an attorney, or through legal proceedings of any kind then in addition the sum of Twenty Five dollars for attorney's fees, as is shown by his note of even date herewith. I agree to pay all taxes while this contract is of force.

It is agreed that time is of the essence of this contract, and if the said payments are not made when due I shall be discharged in law and equity from all liability to make said deed, and may treat said Andrew Lemox as tenant holding over after termination, or contray to the terms of his lease, and shall be entitled to claim and recover, or retain if already paid the sum of Five (\$5.00) Dollars per month for rent, or by way of liquidated damages, or may enforce payment of said note.
