Davis corner; thence S. 72 3/4 W. 13 1/4 ft. to an iron pin, H. H. Griffin's corner; thence N. 19 E. 80 ft. to an iron pin; thence N. 70 1/2 W. 132 ft. to the beginning corner on Mordecai St.; being the same property conveyed by W. B. McGowan, Special Referee to Peoples National Bank, as Executor of Estate of D. D. Davenport, deceased, by deed recorded in the R. M. C. Office for Greenville County in Deed Book 181 at page 284; being the same property conveyed to the grantor herein by the Peoples National Bank, as Executor of the D. D. Davenport Estate by deed dated Feb. 21, 1940, and recorded in the R.M.C. Office for Greenville County in Deed Book 218 at page 349.

ALSO: All that other piece, parcel or lot of land in Ward 4, in the City of Greenville, adjoining lot first above described, and being described by metes and bounds as follows:

Beginning at an iron pin the line of property of Peoples National Bank, which point is 62 ft. from Mordecai Street and 170 ft. from E. Washington St. and running thence with line of property of Peoples National Bank S. 70 1/2 E. 60 ft. to an iron pin; thence with line of property now or formerly owned by Mrs. R. H. Kennedy, N. 19 E. 17 ft. to a point in line of property now or formerly of W. G. Sirrine; thence with Sirrine line N. 72 3/4 W. 65 ft.; thence S. 19 W. 17 ft., more or less, to the beginning corner, together with all buildings and improvements now on said lands.
