~~Beginning at an iron pin on the Paris Mountain Road, joint corner of Lots Nos. 60 and 59, and running thence with the Paris Mountain Road N. 16-17 W. 77.7 feet to an iron pin, joint corner of lots 58 and 59; thence along line of lot No. 58 S. 58-30 W. 200.2 feet to an iron pin; thence S. 31-30 E. 75 feet to an iron pin; thence N. 58-30 E. 180 feet to beginning corner on Paris Mountain Road.~~
