I, E. INMAN, Master in and for the County aforesaid, SEND GREETINGS:

WHEREAS, Ansel M. Hawkins, Committee for Emma G. Moseley, Non Compos Mentis

on or about the 4th day of November in the year of
our Lord nineteen hundred and forty-two exhibited his complaint in the Court of
Common Pleas, for the County aforesaid, against Emma G. Moseley, Maude G. Keating her next of kin and with whom
she resides, Walter B. Pratt, H. M. Pratt, W. O. Pratt, Mrs. J. C. Gore, Maude E. Pratt, Mrs.
S. S. Faulkner, Charles O. Pratt, and Pure Oil Company, a Corporation,

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 11th
day of December, 1943, and such proceedings were had therein as resulted in a Decree

of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for
the County aforesaid, to Dr. S. D. Campbell

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgement Roll No. E-9485)

NOW, THEREFORE, Know All Men by These Presents, That I, E. INMAN, Master in and for the County of Greenville aforesaid, by virtue of the aforesaid
decree,

HAVE GRANTED, conveyed and released, and by these Presents, DO GRANT, convey, and release unto the said
Dr. S. D. Campbell

"All that certain piece, parcel and tract of land situate, lying and being in Gantt
Township, Greenville County, State of South Carolina, and known and designated as Tract No. 7
of the A. J. Moseley estate, according to a sub-division and plat thereof made by H. S. Brockman,
Surveyor, October 12, 1943, and containing 19.27 acres, more or less, and having according to said
plat the following metes and bounds and courses and distances, to-wit:

Beginning at an iron pin on the Eastern side of U. S. Highway No. 25, at corner of Tract
No. 5, and running thence along the center of a road leading from said Highway to Fork Shoals S.
70-05 E. 42 feet to an iron pin; thence along the center of said road N. 82-38 E. 100 feet to an
iron pin; thence N. 70-05 E. 100 feet to an iron pin; thence N. 67-45 E. 744 feet to an iron pin
in the center of said road and in the center of intersecting road leading to the Air Base; thence
along the center of said Air Base road N. 8-00 E. 515 feet to an iron pin in line of the J. D.
Harris property; thence N. 66-00 W. 910 feet to an iron pin; thence S. 14-45 W. 878 feet to an
iron pin in the eastern line of U. S. Highway No. 25; thence along the eastern line of said Highway
S. 10-00 E. 350 feet to the beginning point. The Plat above referred to is now of record in the
R. M. C. Office for Greenville County in Plat Book M, page 87."

The consideration for the above conveyance is the sum of \$2408.75, which amount was paid
by the purchaser direct to the Plaintiff and to the Attorney for the Defendant owners.
