J. T. Hays and Marie A. Hays, their heirs and assigns forever:
All that piece, parcel or lot of land in
on the north side of Buncombe Road and being known and designated as the major portion of Lot
No. 203 and all of Lot No. 204 of the property of Colonia Company as shown on plat thereof
recorded in the R. M. C. Office for Greenville County in Plat Book G, at pages 112 and 113,
and having, according to a survey made in February, 1944, by R. E. Dalton, Engr., the following
metes and bounds to-wit:
Beginning at an iron pin on the north side of Buncombe Road at a point 139 feet west
from the northwest corner of the intersection of Franklin Road with the Buncombe Road, which
point is 1 foot west from the joint corner of Lots Nos. 202 and 203, and running thence along
