V. Langley (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said D. V. Langley, his heirs and assigns forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, located on the branch waters of Reedy River near Paris Mountain, containing 6.3 acres, more or less, and having the following metes and bounds, to-wit:
