NOW, THEREFORE, IT IS ORDERED, ADJUDGED, AND DECREED, That a perpetual easement for the location, construction, operation, and maintenance of a road, in, on, over, and across

All that certain tract or parcel of land situate, lying and being in Gantt Township, Greenville County, South Carolina, and bounded as follows: On the Northeast by other lands of Hendrix; on the Southeast by lands of Shockley; on the Southwest and Northwest by the Greenville Airport Base:

Harris, 31.94 feet to a point; thence parallel to the center line of the road in a southeasterly direction to Station 10 plus 76 of said road, being the property line of R. C. Hendrix; thence S. $69^{\circ} 30'$ W. to the center line of the road; thence along the center line of said road in a northwesterly direction to the point of beginning, containing .61 of an acre, more or less.

All of the above described land is a part of the same land as that described in a deed from John Ferguson and J. P. Miller to E. B. Hendrix, dated November 17, 1892, recorded in Deed Book YY, page 593, in the Office of the Clerk of Court of aforesaid County and State, is hereby vested in the petitioner, the United States of America.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED, That the findings of the jury be, and the same are, hereby confirmed.

IT IS FURTHER ORDERED, That the amount due and payable to Dorothy Lee Hendrix, a minor, be paid to her mother, Idell Hendrix, for the use and benefit of said minor, as said sum is too small to warrant the expense of the appointment of a general guardian for said minor.

IT IS FURTHER ORDERED, That the Clerk of this Court do forthwith issue Registry Fund checks in disbursement of said award as follows:
