to it in hand duly paid at and before the sealing and delivery of these presents by the grantee (S) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell; and release unto Helen Claire Pinson, her Heirs and

Assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the Northwest side of West View Avenue, near the City of Greenville, in the County of Greenville, State of South Carolina, known and designated as Lot No. 11 of Block H, Section 4, on plat of East Highlands Estates made by Dalton & Neves, Engineers, January 1941, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book K, at pages 78, 79 and 80, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the Northwest side of West View Avenue at joint front corner of Lots No. 10 and 11 of Block H, and running thence with the line of Lot No. 10, N. 53-00 W. 211.7 feet to an iron pin on the Southeast side of a 10 foot strip reserved for utilities; thence with the Southeast side of said strip reserved for utilities, S. 34-13 W. 63.1 feet to an iron pin; thence with the line of Lot No. 12, S. 53-00 E. 208.6 feet to an iron pin on the Northwest side of West View Avenue; thence with the Northwest side of West View Avenue N. 37-00 E. 63 feet to the beginning corner.
