to it in hand duly paid at and before the sealing and delivery of these presents by the grantee (s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Guy R. Coker, his heirs and assigns:-

All that certain piece, parcel or lot of land situate, lying and being on the southeast side of Parkins Mill Road near the City of Greenville, in the County of Greenville, State of South Carolina, known and designated as Lot No. 4 of Block H in Section 4 of East Highlands Estates as shown on plat made by Dalton & Neves, Eng. Jan. 1941 and recorded in the RMC Office for Greenville County in Plat Book K at pages 78, 79 and 80, and having according to said plat the following metes and bounds to-wit:

Beginning at an iron pin on the southeast side of Parkins Mill Road at joint front corner of Lots 3 and 4 of Block H and running thence with line of Lot 3, S. 58-37 E. 205.3 feet to an iron pin on the northwest side of a ten foot strip reserved for utilities; thence with the northwest side of said strip reserved for utilities; ~~thence with the northwest side of said strip reserved for utilities, S. 34-13 W. 66.1 feet to an iron pin; thence with line of Lot No. 5, N. 58-37 W. 202 feet to an iron pin on the southeast side of Parkins Mill Road; thence with the southeast side of Parkins Mill Road N. 31-23 E. 66 feet to the beginning corner.~~

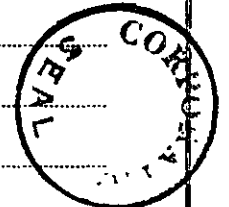
