All that certain lot of land in Cleveland Township, Greenville County, State of South Carolina, being Lot No. 33 of Section A of a SUNDIVISION of D. B. Tripp's land at River Falls, as per plat of said subdivision made by W. A. Hester, Surveyor, April 21, 1926, which plat is recorded in R. M. C. Office for said County in Plat Book G, page 89, said lot having a frontage of 70 feet on a 30-foot Road, with a depth of 200 feet.

This conveyance is made subject to the following conditions: The said property shall not be used for business purposes, but shall be used for residential purposes for white people only (this not to apply to servants); no hogs shall be kept on said property; and no sewage shall be emptied into any creek or stream.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the granted (s) hereinabove named, and her heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee (s) hereinabove named, and her heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
