CHARTER  
BY THE SECRETARY OF STATE.

WHEREAS,

did on the 29th day of April, 1944, file with the Secretary of State a written Declaration, signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is

SOUTH CAROLINA ADVANCE STORE COMPANY, INCORPORATED.

THIRD: That the principal place of business is

FOURTH: That the general nature of the business which is proposed to do is

To manufacture, buy, sell, trade and deal, at wholesale and retail, in and with supplies, accessories, equipment, specialties, parts and appliances used and connected in any way with automobiles, motor trucks and vehicles of all kinds.

To manufacture, buy, sell, import, export, rent, lease, repair, trade and deal in and with radiophones, radio apparatus, electrical, magnifying and reproducing devices of all kinds, sports supplies, sporting goods, and any and all equipment, appliances or devices used in connection therewith.

To manufacture, buy, sell, trade and deal, as principals and agents, at wholesale and retail, in and with furniture of all kinds, carpets, rugs, bedding, house furnishings, hardware, paints, household goods and equipments, electrical appliances, and articles and general merchandise of every class and description.

To act as purchasing and selling agents and distributors for persons, firms, associations, and corporations.

To manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, assign and transfer, or otherwise dispose of, to invest, trade, deal in and deal with, goods, wares and merchandise and personal property of every class and description.

To acquire, and pay for in cash, stock or bonds of this corporation or otherwise, the good will, rights, assets and property, and to undertake or assume the whole or any part of the obligations or liabilities of any person, firm, association or corporation.

To acquire, hold, use, sell, assign, lease, grant licenses in respect of, mortgage, or otherwise dispose of letters patent of the United States or any foreign country, patent rights, licenses and privileges, inventions, improvements and processes, copyrights, trade-marks, and trade names relating to or useful in connection with any business of this corporation.

To purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of shares of the capital stock, of, or any bonds, securities or evidences of indebtedness created by any other corporation or corporations organized under the laws of this State or any other State, country, nation or government, and while the owner thereof to exercise all the rights, powers and privileges of ownership, including the right to vote.

To enter into, make and perform contracts of every kind and description with any person, firm, association, corporation, municipality, county, state, body politic or government or colony or dependency thereof.

To borrow money for the purpose of carrying out the objects of the corporation and from time to time, without limit as to amount, to make, accept, endorse and issue promissory notes, bonds and other evidences of debt and to secure the payment of any of its obligations by mortgage or deed in trust on all or any of its property and franchises, both real and personal.

To have one or more offices, to carry on all or any of its operations and business and without restriction or limit as to amount to purchase or otherwise acquire, hold, own, mortgage, sell, convey, or otherwise dispose of real and personal property of every class and description in South Carolina and any of the States, Districts, Territories or Colonies of the United States, and in any and all foreign countries, subject to the laws of such State, District, Territory, Colony or Country.

In general, to carry on any other business in connection with the foregoing, whether manufacturing or otherwise, and to have and exercise all the powers conferred by the laws of South Carolina upon corporations formed under the Act hereinafter referred to, and to do any or all of the things hereinbefore set forth to the same extent as natural persons might or could do.

To objects and purposes specified in the foregoing clauses shall, except where otherwise expressed, be in nowise limited or restricted by reference to, or inference from, the terms of any other clause in this Declaration for Charter, but the objects and purposes specified in each of the foregoing clauses of this Article shall be regarded as independent objects and purposes.
