Haynsworth was substituted as Trustee in the place and stead of the said Knox L. Haynsworth by order of Honorable G. Dewey Oxner, Circuit Judge, dated November 19, 1943, filed in the office of the Clerk of Court for Greenville County in Judgment Roll E-9758; and

Whereas, Rhoda L. Haynsworth as Trustee is now the legal owner and holder of the lot hereinafter described and the grantor desires by this deed to convey to said Trustee any and all interest which may appear to be vested in him to the real estate hereinafter described, on account of the incorrect description of the property contained in the said deeds above set forth.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That I, D. B. Traxler in the State aforesaid, in consideration of the premises and the sum of One Dollar to me in hand paid at and before the sealing of these presents by Rhoda L. Haynsworth as Trustee, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell, quit claim and release unto the said Rhoda L. Haynsworth, as Trustee, her Successors and Assigns:-

All that certain piece, parcel or lot of land situate, lying and being on the West side of North Main Street in the City of Greenville, County of Greenville, State of South Carolina, and having the following metes and bounds, to-wit:

Beginning at a stake on the West side of North Main Street at the Northeast corner of lot heretofore conveyed by D. B. Traxler to Wallace W. Riddick by deed recorded in the RMC Office for Greenville County in Deed Book 45 at page 370, and running thence with said Riddick line in a Westerly direction 133 feet, more or less to an iron pin; thence N. 5½ E. 51 feet more or less to an iron pin at corner of lot heretofore conveyed to D. B. Traxler to W. M. Jordan by deed recorded in the R. M. C.
