The following described piece parcel or lot of land situate lying and being in the County and State aforesaid, on the East side of the Paris Mountain Road known and designated as Lots numbers 9 & 10 in and on a Plat of Paris-Piney Park, recorded in the R. M. C. Office in and for Greenville County in Plat Book "H" at pages 19 & 20.
