TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said
Charles T. Whitaker, Jr., his heirs and assigns forever; subject, however, to the limitations and conditions hereinbefore imposed.

And it does hereby bind itself and its successors in office to warrant and forever defend all and singular the said Premises unto the said
