Truman H. Henderson, his heirs and assigns forever:

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina.

on the west side of the Mostella Road, near the town of Greer, containing two and 20/100 (2.20) acres, and bounded on the northeast and east by the Mostella Road; on the southeast and south by lands formerly of E. B. Crain, now of grantee; and the Wilson Cemetery, and West by lands of Nancy W.
