

TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, That Surety Mortgage Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Two Hundred and Seventy and no/100 (\$270.00) DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto A. E. Brown and Juanita Brown, their heirs and assigns forever:-

All that certain piece, parcel or lot of land situate, lying and being on the Northeast side of Morningdale Drive, near the City of Greenville, in the County of Greenville, State of South Carolina, known as Lot No. 18 of Block K, on plat of Northgate, recorded in the R. M. C. Office for Greenville County, in Plat Book G, at page 135 and 136, revised plat being in Plat Book M, at page 13, and having, according to said plats the following metes and bounds, to-wit:

Beginning at an iron pin on the Northeast side of Morningdale Drive at joint front corner of Lots No. 17 and 18 of Block K and running thence with the line of Lot 17, in a Northeasterly direction 204.6 feet to an iron pin; thence S. 2-29 W. 90 feet to an iron pin; thence with the line of Lot 19, in a Southwesterly direction 141.7 feet to an iron pin on the Northeast side of Morningdale Drive; thence with the Northeast side of Morningdale Drive, N. 37-28 W. 100 feet to the beginning corner.

This property is conveyed subject to the following restrictions and reservations:-

- (1) No building shall be erected nearer than 40 feet to Morningdale Drive.
- (2) No dwelling shall be erected on said lot costing less than \$3,000.00.
- (3) This lot shall be used for residential purposes only, except this shall not apply as to Section D on the plat above mentioned.
- (4) The property shall not be sold, rented or otherwise disposed of to persons other than of the Caucasian race.
- (5) No obnoxious or offensive trade shall be carried on on the property.
- (6) No building of a temporary structure shall be erected on the property for use as a residence.
- (7) An easement is reserved along the rear line of the lot, two (2), feet in width, for the purpose of placing sewerage, telephone and electric lines or other utilities, with the right of entry for maintaining and repairing said utilities.

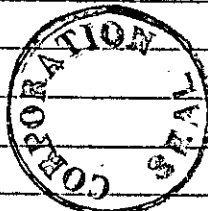
RELEASE.
