All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina.

School District 9-C, on the south side of the road leading from the west side of Paris Mountain Road to the home of the grantor herein, and being more particularly described as follows:

BEGINNING at an iron pin on the west side of the aforesaid road at the corner of Lot No. 20, of a subdivision known as Paris Mountain Farms, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book N, at page 13, which point is in the line of the property of grantor, and running thence along the line of Lots Nos. 20, 21 and a portion of 22, N. 73-15 W. 225 feet, more or less, to the point in the front line of Lot No. 22, where the line of the grantor intersects the south line of the aforesaid road, and running thence along the southern side of the aforesaid road, in a generally southeastern direction, approximately 250 feet to the beginning corner.
